

CAN YOU GIFT AID YOUR DONATIONS?

Let your guests know that by gift aiding their donations, they help us to claim an additional 25% in every pound donated, at no extra cost to them.

To be eligible to gift aid your donation, all of the following statements must be true:

1. I am a UK taxpayer.
2. This donation is my own money. It has not come from anyone else or a collection.
3. This donation is voluntary, and not the proceeds from a sale.
4. I'm not in with the chance to win a prize from this donation e.g a sweepstake or raffle.

Make sure your guests write their **full name, home address and postcode** on the form, so we can claim gift aid. The form must be completed in their own handwriting.
