



If a family lives in West Yorkshire and has a child (under the age of 18) with a life-limiting condition or their child has died (16+ weeks into a pregnancy or up to 18 years old) in the last 2 years, then they meet Forget Me Not's eligibility criteria.

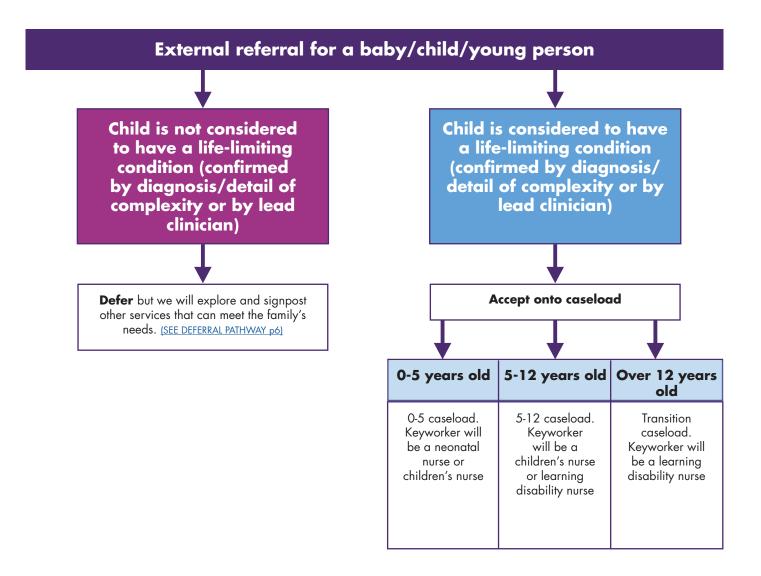

### Support for babies, children and young people

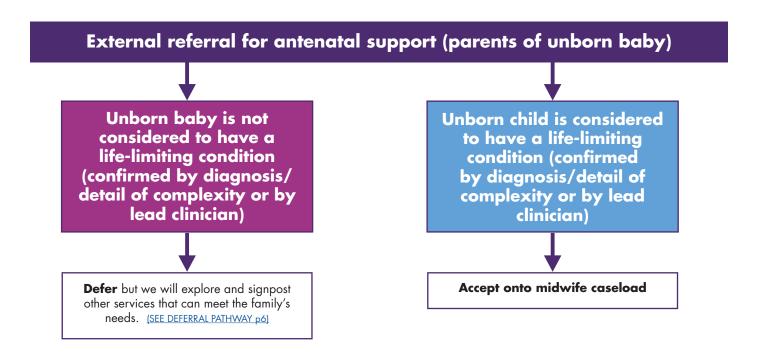
We support babies, children and young people with clinical care including ongoing symptom management, advanced care planning and liaising with the team supporting the child. We also provide respite care, short breaks, creative therapy, hydrotherapy and sensory play, activities and days out to help them live as full a life as possible.



**Summary:** Family live in West Yorkshire. Their child has a life-limiting condition and is aged 0-18 at time of referral.

## **Support during pregnancy**

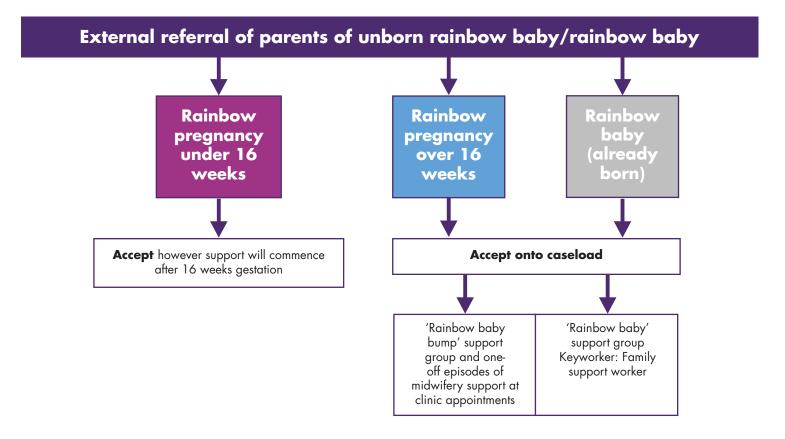
Our midwife supports families during pregnancy by attending antenatal appointments, helping with birth plans and enabling them to make informed choices at all stages of their pregnancy.



**Summary:** Family live in West Yorkshire. From 16 weeks+ gestation, with unborn baby diagnosed as having a potential life-limiting or life-threatening condition.

#### Support for parents of rainbow babies

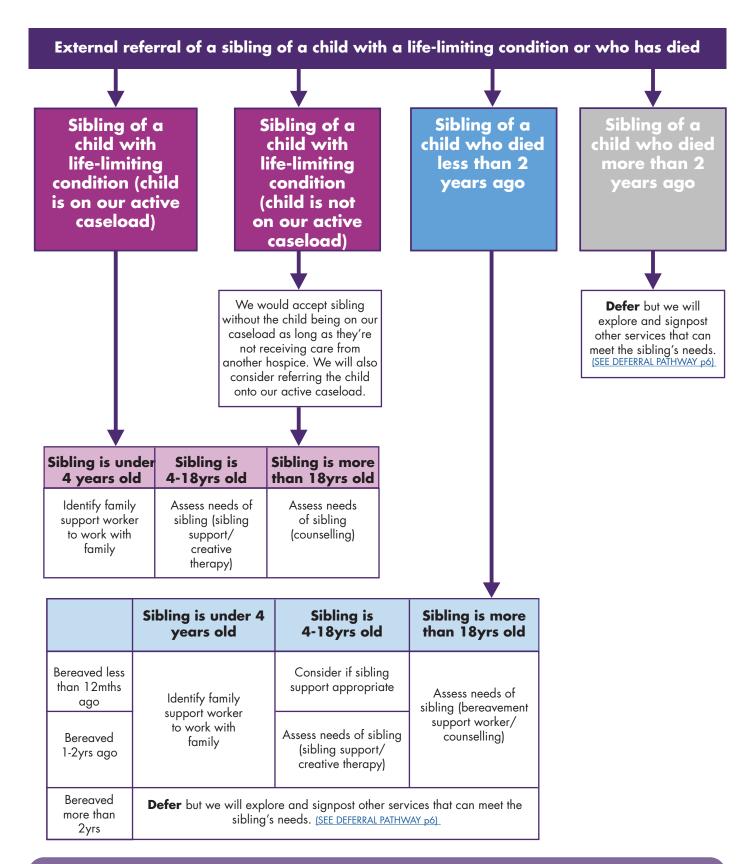
We support families who are having or have had their first healthy baby following the loss of a baby with peer to peer support and access to our midwife, to help improve their mental and emotional wellbeing at what can be an anxious and challenging time.



**Summary:** Family live in West Yorkshire. Currently experiencing first healthy pregnancy (16+ weeks gestation) or first healthy baby (up to 1 year old) following the loss of a baby.

### Sibling support

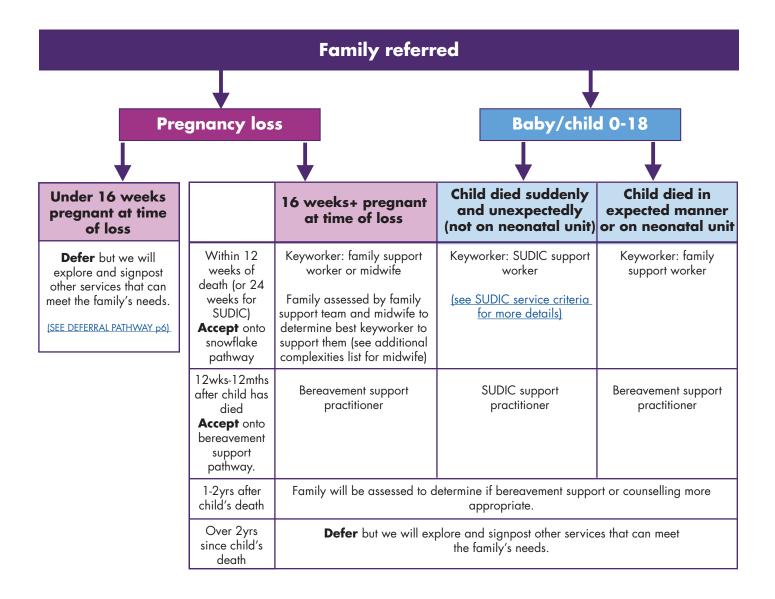
We support siblings of children with life-limiting conditions or who have died with counselling, creative therapy, bereavement support and activities to help them express and deal with their anxiety, grief and confusion about their brother or sister.



**Referral summary:** Child/young person lives in West Yorkshire. Have either a sibling with a life-limiting condition (including unborn) on our caseload or a sibling (including unborn) who has died within the last 2 years.

### Support for families following a bereavement

We support families whose baby or child has died with bereavement support, counselling and therapy to help them feel better able to cope with their grief, improve their mental and emotional wellbeing and build their resilience.



**Summary:** Family live in West Yorkshire. Their child died from 16 weeks pregnancy up to 18 years old. Referred within 2 years of the child's death/loss in pregnancy.

### **Deferral Pathway**

#### What happens if a child or family does not meet our eligibility criteria

#### At referral panel:

- We will allocate a named person to follow up with the family
- Record the reason for deferral on our records system (SystmOne)
- Ensure this is followed up and fed back in a timely manner.

#### Allocated person to:

- 1) Explore other services that can meet need for this family
- 2) Contact family within 3 days of panel to inform them of decision made and alternative options of service provision. Ensure this information is relayed sensitively by telephone or in person
- 3) Ensure referrer also informed of deferral/reason and alternatives suggested
- 4) Document conversations on SystmOne
- 5) Feedback at next panel.

Please note all children and families must live in West Yorkshire.
