FOOD

If you're struggling to pay for food, you're not alone. Food shopping can be one of the biggest bills and it's becoming harder to afford the essentials as prices increase.

Regular meals are important to keep yourself and your family healthy so it's important you don't go without.

Checking you're claiming all you're entitled to could help to maximise your income and ease the burden. There are free online tools you can use to check your income. Details of these can be found under the '*Money*' section in this booklet.

ENERGY

A massive rise in the cost of gas and electric that suppliers pay has sent household energy prices soaring.

The market is unpredictable which means advice can change rapidly.

Usually when energy bills go up, the best advice is to shop around for a cheaper deal, but there's very few on the market right now. However, you can still get help to manage your bills.

Firstly, don't be afraid to tell your supplier straight away if you are finding it hard to pay. Suppliers will provide specialist advice and support to find a solution before things get worse.

Grants are available to clear domestic gas and electricity debts. But before you apply for these grants, get some free advice from a reputable agency like those listed below to make sure they're the right option for you.

Energy Bill Discount scheme

The government has announced funding for all energy suppliers to pass on to domestic electricity customers from October 2022. Each home could qualify for a £200 cash discount on Autumn bills. This money DOES need to be paid back in equal instalments of £40 each year over five years, starting from financial year 2023-24. More information will become available about the scheme in the near future.

Cold Weather payment

An automatic payment if you're getting certain benefits or Support for Mortgage Interest and the average temperature in your area is recorded as zero degrees celsius or below over seven consecutive days.

If you're on a low income or get Guarantee Credit element of Pension Credit you could qualify for a one-off discount on your winter energy bill.

Winter Fuel Payment

If you were born on or before 26 September 1955 you could get between £100 and £300 towards your heating bills. Most payments are made automatically in November or December.

Council Tax Energy Rebate 2022/23

The government has introduced a £150 one-off payment to help people with rising energy costs. The money will be paid from around April 2022 to council tax payers living in a property in band A to D (find this on your council tax bill).

If you pay your council tax by direct debit you'll receive the payment automatically. If you don't pay by direct debit, you may need to apply for the rebate.

This money is NOT a loan and does NOT need to be paid back.
